SELLER REPRESENTS:

The Golden Retriever puppy that you as the buyer are purchasing from Stormy Point Goldens Kennel is in good health at the time the buyer assumes ownership. Great care has been given to each puppy to ensure the puppy is free of parasites, fleas, intestinal worms and ear mites. The above named puppy is current on shots and deworming. The above named puppy has been examined by a licensed veterinarian and found to be in good health. The puppy is being sold with AKC Limited Registration. I do believe this puppy to be of Pet quality. This puppy is being sold on a spay/neuter contract.

The consideration of this sale shall be for the sum of \$_____.

A non-refundable deposit was taken for the sum of \$200. Deposit is only refundable if Stormy Point Goldens cannot provide a puppy. The remaining balance is due upon pick-up of the puppy at 8 weeks of age. If arrangements have not been made to pick-up the puppy by 10 weeks of age the deposit will be surrendered.

All pet/companion puppies include a health guarantee until the age of 2 years old against genetic defects (hip, heart, eyes). Proof of defect must be submitted to Stormy Point Goldens by a specialist in the said field of defect. Defect must be life altering for guarantee to apply. A hip rating of Mild or below from OFA must be proved for the hip guaranteed to apply. Life altering heart defect would be a grade 2 or above heart murmur. If defect is valid Stormy Point Goldens will replace the dog with a puppy from a future litter. At no time will any money be refunded and we will not be liable for any vet bills. Owner is allowed to keep original puppy also. This health guarantee is only valid if the pup is kept on a premium large breed puppy food until the age of 1 and the dog must be kept on a premium large breed adult formula. The pup must also be kept on Nuvet Supplements until 1 year of age. The health guarantee is void if the owner allows the puppy to become more than 15 pounds overweight based on the AKC Golden Retriever standard. Stormy Point Goldens has the right to have the dog examined by a vet of our choosing for a 2nd opinion. All pups must have the pre-fix Stormy Point in the AKC Registered name. Stormy Point/Jan Grasso will not be responsible for any vet costs incurred by the buyer of this puppy.

All Show/Breeding pups must have the prefix Stormy Point included in their AKC Registered name and will be covered by a 2 year health guarantee against genetic defects (hip, heart, eyes). If a genetic defect is found within 26 months of age I will replace the puppy or refund the purchase price (excluding vet and shipping costs) upon return of the animal and all AKC paperwork. I must be submitted proof of defect from OFA or specialist in that said field. Owner of Show/Breeding puppy must obtain OFA hip and heart

clearances before breeding the animal. Stormy Point Goldens also requires a Eyes Cerf. Guarantee is valid only to original owner. Breeder has first right of refusal and must approve all future placement.

The Health Guarantee is only valid if proper care has been given to the dog. The dog must have an annual vet exam and is required to be current on all shots and deworming. Dog must be provided heartworm and flea and tick preventive on a regular basis.

THE BUYER AGREES:

The buyer agrees that the puppy will be examined by a licensed Veterinarian within 72 hours of receipt. If the puppy is determined to be ill or if found to be unacceptable I will refund the full purchase price or will replace the puppy.

The buyer agrees to keep the puppy on a large breed premium dog food. Buyer understands that this is a condition for the health guarantee.

The above named animal **WILL NOT** chained in a yard or mistreated in any manner. The primary reason for purchase of this animal is for Pet/companion. The buyer agrees to train, groom, and provide for this animal as needed. Buyer agrees that any abuse or neglect will constitute surrender of this animal to Jan Grasso. **THE BUYER AGREES THAT THE DOG WILL BE AN INSIDE FAMILY PET.**

The buyer will have the dog spayed or neutered by 9 months of age. If the seller doesn't receive proof of the spay or neuter by the age of 11 months the seller has the right to regain ownership and custody of the dog.

If at any time the buyer can't care for the animal it will be returned to Jan Grasso or Jan Grasso must approve future placement of the dog. For no reason will the dog be surrendered to an animal shelter or medical research facility. The buyer/seller is perfectly clear that the animal can be returned to Jan Grasso with no questions asked. _____ INITIAL

The buyer will provide proper medical care such as annual vaccinations, deworming, heartworm preventive and flea and tick preventive.

All parties agree to the above conditions. Both parties have read and understand this document.
